Dear President:

This will confirm our conversation and our firm's subsequent employment as Town Attorney for the Town of Lapel, Indiana, pending Town Council approval.

I.

GRAHAM, FARRER & WILSON, P.C. (the "Attorneys") to represent the Town of Lapel (the "Town") with respect to the following general matters:

- 1. Attending all meetings of the Town Council and other Town meetings as requested and agreed upon by the parties.
- 2. Counseling the Town Council, its members, and other Town personnel and boards.
- 3. Drafting routine documents, motions, correspondence and ordinance modifications for the Town Council and other Town bodies as requested.
- 4. Routine telephone calls from Town Council members and other authorized personnel of the Town concerning any matters relating to routine administration matters.
- 5. Routine litigation from administrative issues.

For those services, the Attorneys will be paid the sum of Seven Hundred Fifty Dollars (\$750.00) per month.

II.

Any non-routine non-litigation matters shall be billed to the Town at the rate of Two Hundred Fifty Dollars (\$250.00) per hour.

Pursuant to I.C. 22-5-1.7-11, the firm shall enroll in and verify the work eligibility status of all newly hired employees through the "E-Verify" program. The firm shall not verify the work eligibility of all newly hired employees if the "E-Verify" program no longer exists.

The firm represents that it does not knowingly employ any unauthorized alien. (See Affidavit attached hereto as Exhibit "A").

## IV.

If the Town wishes to retain the services of the Attorneys for any litigation or court proceedings, attorneys' fees for representation of the Town in such matters shall be calculated at the hourly rate of Three Hundred Dollars (\$300.00) per hour. All such services shall be performed without advance fee.

The Attorneys shall be reimbursed for all costs and expenses incurred in handling such matters, including, without limitation, filing fees, computer assisted legal research, photocopy and long-distance telephone charges.

If the above meets with the Council's approval, please return a duly executed copy to me.
