SMOKE TESTING SERVICES

R&R Visual, Inc will utilize Hurco Ripcord smoke testing equipment to complete all smoke testing on this project. Liquid smoke will be heated up by exhaust system from blower, and then forced into the sewer lines. This will push smoke up lines in both directions of testing equipment. R&R will capture images of each location that smoke is exiting the ground, lateral lines, and storm connections along with a written log that states the closest road and address to each problem area. Testing will begin at a dead end area and work methodically through the system following flow towards the flows end point. Final reports will include all still images with geo location and a written report detailing problem areas.

Town of Lapel or CDS Engineers will be responsible for widespread public notification including but not limited to fire department, police, schools, hospital, and all residents in smoke testing area.

PROJECT GOALS

- Record high quality photos of observations with reporting in a easy to navigate format
- Fluid communication between Owner and Project Manager
- Communication with effected residents and public education as questions arise.

ESTMATED PROJECT SIZE

35,000' of smoke testing

PROJECT TIMELINE

R&R Visual has estimated production of 4,500 - 7,000 linear feet per day depending on mainline diameter and noted defects. It is anticipated that smoke testing will be completed in 5-8 days on site.

TRAFFIC CONTROL

Traffic control permits, etc. are to be provided by the customer if needed. Traffic control will be necessary for this project and will consist of cones, on-board arrow signals. No traffic control is required on state roads. The testing will be moving around a lot during the inspections and R&R will be sure to have the work zone clearly identified to motorists and pedestrians.
